The undersigned is directed to say that WBCS(Exe) officers in their movement to pre-revised pay-scales no.19 & 21 had been allowed two(2) additional increments in each level, on the date of fixation in the corresponding scale of pay, on their basic pay, which will be arrived at after fixation in the pay scales as above, commencing notionally w.e.f. 01.07.2016 and actually w.e.f. 01.12.2016 – vide this Department's Notification No.39-PAR(WBCS)/1D-318/18 dated 16.01.2017.

Now, a question has arisen, whether those additional increments allowed exclusively to the WBCS(Exe) officers and not to any other state services, shall be factored in while fixing pay under AIS (Pay) Rules, on being promoted to I.A.S., in terms of IAS (Recruitment by promotion) Rules.

After careful consideration of the matter, the Governor is pleased to order that such benefit allowed to WBCS(Exe) officers exclusively shall not be counted towards fixation of their pay in services other than State Services (e.g. AIS posts), while the same shall continue to be allowed to WBCS(Exe) Officers so long they are in the State Services.

Finance Department has given their concurrence in the matter vide their U.O. No. Gr.P1/2017-18/0368 dated 10.01.2018.
